CHECKLIST FOR NEW ITEM PACKET

The following information must be included in your New Item Packet:

	Vendor contact information, including an e-mail address. If you use a billing address that is different from your facility or farm address, please include both.
	List of products available, including seasonal information if applicable
	Ingredient lists
	Country, State, and County of origin
	Actual product samples of non-perishable products
	Actual packaging samples of perishable products
	For food manufacturing businesses in Tennessee, a copy of your Tennessee Dept of Agriculture Regulatory Services
	Permit and a copy of your last inspection report. Businesses outside of Tennessee must provide their state's equivalent permit and inspection documentation.
	Copy of additional relevant permits, licenses, and/or inspection forms from the Tennessee Department of Agriculture,
	Tennessee Department of Health, and/or the USDA required for you to sell to retail establishments. See back for list of products requiring licenses.
	Cost and terms offered. Minimum of 7 day terms required
	Sample of invoice to be provided
	List of current Tennessee retailers carrying the product. If you retail your own product at farmer's markets, on the Internet, or in other ways, include those along with your retail prices.
	Other pertinent information, such as marketing materials in use.
The follow	wing information must be included if available:
	Product UPC
	Nutritional information
	Organic Certificate
	Certified Naturally Grown Certificate
	Humane Raised and Handled Certificate
	Animal Welfare Approved Certificate

To be considered, products must meet the Three Rivers Market Product Standards. A copy of our current standards is attached.

Farms not Certified Organic or Certified Naturally Grown must be visited by Three Rivers Market. Products submitted with incomplete information will not be considered. A Note about GMOs:

We recognize that consumers expect natural and organic products to be free of GMOs and are endeavoring to meet that expectation to the best of our ability. Therefore we are no longer accepting new non-organic food products that include GMO highrisk items (listed below) in their ingredient list, unless they are enrolled in the Non-GMO Project or can provide us a detailed description of measures taken to avoid GMO contamination. We also prioritize body care items, pet supplies, and general merchandise that do not contain genetically modified ingredient.

- High-risk crops include:
 Alfalfa
 - Canola
 - Corn
 - Cotton

- Papaya
- Soy
- Sugar Beets
- Zucchini and Yellow Summer Squash

REQUIREMENTS AND REGULATORY INFORMATION

Farm products include, but are not limited to: produce, plants, eggs, honey, meat, cheese, milk, decorative gourds, herbs, animal fibers and cut flowers. Farm vendors cannot change food from its original state without approval from the Tennessee Department of Agriculture Regulatory Services. This includes jams and jellies, shelled beans or sliced watermelon. Baked goods & value added products are considered a "Prepared Food" and require permitting by the Tennessee Department of Agriculture.

Products requiring licenses include:

- Eggs: Eggs from vendors with under 3000 birds which are sold as unclassified or ungraded must be in containers that are labeled with the name and contact information of the producer and must be clean and sanitized.
- Meat: Must be processed in a USDA certified facility. All meat products offered for sale must have the USDA seal.
- **Honey:** Honey processors who produce less than 150 gallons of honey per year are not required to obtain a Regulatory Services Permit. The product must still be labeled with contact information, net weight in ounces and grams and ingredients.
- Cheese and Milk Products: All dairy products sold in Tennessee must be registered.
- **Plants:** Vendors selling rooted plant materials have to be certified by Tennessee Department of Agriculture before selling their nursery materials. Exceptions include tomato, squash & eggplant starts. All bedding plants, strawberries and herbs require a license. There are several types of nursery, greenhouse or plant dealer applications. A description of the various applications can be obtained from Tennessee Department of Agriculture Division of Regulatory Services.
- **Prepared Foods:** All prepared foods must be sold in compliance with Tennessee Department of Agriculture and Knox County Health Department regulations. All packaged foods must be labeled with vendor contact information, ingredients and net weight.
