GUIDELINES

- Our preferences are for non-profit organizations located in the communities served by Three Rivers Market in Knox, Blount, Anderson, and Sevier counties. Our donation program does not subsidize partisan organizations or programs that advance a particular religious belief.
- Non-profit organizations must make it easy to find critical information about the organization. A listing of the current members of your Board of Directors and the most recent Form 990 should be accessible on the organization's website or Tennessee Secretary of State's listing of Charitable Organizations registered in Tennessee.
- We make cash and in-kind contributions greater than \$100 to events with other small, local, and/or cooperative businesses and organizations only. If you are receiving support for your event from large, non-local corporations or organizations, we will not be able to contribute.
- Priority is given to organizations that support us too, showing a commitment to small local businesses and the local economy.

DEADLINES

- For requests of \$100 or less, applications must be received no later than two (2) weeks in advance of the event.
- For requests of \$101-\$500, applications must be received no later than eight (8) weeks in advance of the event.
- For contribution and sponsorship requests greater than \$500, applications must be received no later than twelve (12) weeks in advance of the event.

Please attach an Annual Report, brochures, or any relevant promotional information pertaining to your event and/or organization. Please note that we cannot review your request until *all information* has been submitted to Three Rivers Market.

Your organization is required to furnish us with a receipt upon receiving any in-kind contributions. Thank you!
